

# 2020 Social Circle High School Prom – 9/10 Date Form

This year's prom will be held on Saturday, April 18th, at Classic Center-Empire Room in Athens, GA from 7:30 p.m. until 11:30 p.m. Permission slips must be submitted by Thursday, April 3rd.

## Section I: Attendance/Tickets

1. ALL STUDENTS MUST submit a Prom Permission slip signed by a parent or guardian by April 3rd.
2. If your date is a SCHS student that is not in 11th/12th grade or your date is a Non-SCHS student, you must purchase a Prom ticket for \$30 by April 3rd.
3. YOUR PROM DATE must be submitted by April 3rd or your date will not be allowed to attend Prom.
4. Guests/Dates must be at least a high school freshman and must not be older than 20 as of April 18, 2019.
5. You may ONLY see Ms. Taylor to pay your dues or purchase your date's prom ticket; otherwise we are not responsible for your payment.
6. NO TICKETS WILL BE SOLD OR DUES WILL BE ACCEPTED AFTER 3:30PM ON WEDNESDAY April 3rd. ABSOLUTELY NO EXCEPTIONS. This includes being absent on that day! Security issues dictate this policy.
7. Students who have been expelled or sent to the alternative school cannot attend the prom. Early graduates may attend as guests only, but may not purchase tickets.
8. To be admitted to the prom, you must present: your ID and your guest's ID. Failure to produce these items at the door will result in your not being admitted to the prom.
9. NO REFUNDS ON TICKETS OR DUES FOR ANY REASON. This includes if you choose not to attend Prom or if you are not admitted to Prom.

## Section II: Attire and Conduct

1. The prom is a formal dress occasion. All students must be in formal attire. Failure to dress properly will result in not being admitted to the prom.
2. Dancing must remain appropriate to a school environment. Suggestive or dangerous dancing will be stopped and those participating will be removed from the premises.
3. Students are responsible for the behavior of any invited guest.
4. Once admitted to the prom, you will not be allowed to leave and re-enter. THIS INCLUDES GOING TO YOUR CAR.
5. Students may not enter off-limits areas of the Classic Center building.
6. Absolutely no tobacco, alcohol, or drugs of any nature are permitted at the prom.
7. The parents and student assume responsibility for any accident or property damage while attending and traveling to and from the prom.
8. If a student is asked to leave by a chaperone or Classic Center employee and refuses, the proper legal procedures will be followed.
9. All rules and regulations of Social Circle High School will be followed.
10. The administrators of Social Circle High School reserve the right to make any other decisions needed to ensure a safe night for our students.

### DRESS CODE FOR LADIES

- No necklines (v-cut, plunging, etc.) that extend below the breast line.
- Two piece dresses do not need to expose more than hand width of skin
- No open back that extends below the waist-line.
- Slits and length of dress can be no higher than fingertip length.

### DRESS CODE FOR GENTLEMEN

- Formal attire: coat and tie OR tux required
- No gym shoes
- No jeans

**ALL STUDENTS WILL BE CHECKED UPON ARRIVAL. IF THEIR ATTIRE DOES NOT MEET THE REQUIREMENTS, THEY WILL NOT BE ADMITTED TO THE PROM!!**
